REGULAR SESSION
April 14, 2011

The Unicoi County Board of Education met on Thursday, April 14, 2011 in Regular Session at 6:00 p.m. at the Central Office. The meeting was called to order by chairman, Renea Jones Rogers. The invocation was given by Victor Price and the Pledge to the American Flag was led by Judy Webb.
